### **ABOUT THE SCHOLARSHIPS**

In 2015, OceanFirst Foundation will provide \$50,000 grants to Brookdale Community College, Georgian Court University, Ocean County College and Monmouth University for the purpose of awarding scholarships for undergraduate education. Scholarships will be awarded by each College/University as follows:

#### *Community Colleges*

- Brookdale Community College – Fifty (50) \$1,000 Scholarships
- Ocean County College – Fifty (50) \$1,000 Scholarships

#### *Universities*

- Georgian Court University – Twenty (20) \$2,500 Scholarships
- Monmouth University – Twenty (20) \$2,500 Scholarships

### **MINIMUM ELIGIBILITY REQUIREMENTS**

- Applicant must be an incoming full-time freshman for the fall semester of 2015.
- Applicant must be a 2015 graduate from a High School within the OceanFirst Bank market area. Please refer to page 3 for a list of eligible school districts.
- Applicant must currently reside in the OceanFirst Bank market area. Please refer to page 3 for a list of communities in the OceanFirst market area that meet the residency requirement.
- Applicant must have a minimum GPA of 3.0 at the time of application for admission and must provide a copy of their high school transcript.

### **USE OF SCHOLARSHIP**

Scholarship recipients may only use the scholarship for tuition, fees or books.

### **SELECTION**

Each College/University will evaluate all scholarship applications and select recipients based on the College/University's existing policies and procedures for awarding scholarships. Selection decisions are made completely independent of the OceanFirst Foundation. Representatives from OceanFirst Bank and OceanFirst Foundation, including all employees and board members, do not participate in the selection process.

Please note that if you are selected to receive an OceanFirst Foundation Scholarship, your attendance will be strongly encouraged at a Scholarship recognition event in summer 2015.

**TO APPLY**

Please complete the application and mail to the appropriate College/University as noted below. If applying to Ocean County College, you are also required to complete the Free Application for Federal Student Aid (FAFSA) which can be found at [www.fafsa.gov](http://www.fafsa.gov). You must also provide a copy of your high school transcript. Your application must be received by the noted deadline to be considered for this scholarship. We highly recommend you contact the school to which you are applying to confirm the receipt of your application.
